

PRIVACY STATEMENT FOODJET B.V.

This is the Privacy- and Cookie Statement of the website www.foodjet.com (hereinafter referred to as: 'Website') and relates to your relationship with us (as a customer) in general. This statement applies to all personal data that Foodjet B.V. and its subsidiaries (hereafter 'Foodjet' or referred to as 'we', 'our' or 'us'), process of its website visitors via the Website and/or generated out of its business systems (hereinafter referred to as: 'you' and 'your data'). Foodjet will process personal data in compliance with the General Data Protection Regulation ('GDPR').

1. Which personal data we process and for what purposes

Personal data is any information that directly or indirectly identifies a natural person. Foodjet processes the following information, which may qualify as personal data relating to you: name, address, position within the company, company details, telephone number, e-mail address, IP-address .

We process your data for the following purposes:

(A) Communication with (potential) customers

We process contact information of (potential) customers in order to be able to communicate with them about questions, orders and delivery of products.

(B) Sending information about coming events

We are often present at fairs and events. In order to be able to inform you about coming fairs and events, we process e-mail addresses and (if you provide us with such information) name, initials and additional information like company name or functional classification of our customers and, in case we have met new clients at previous events, potential customers. If you receive such an email, we may use your online clicking behaviour to personalize our newsletters and Website for you, for which you are explicitly requested to provide your consent in advance ('opt in'). You are at any time allowed to withdraw your consent for receiving our information emails.

(C) Applicants

We only use applicants' personal data for recruitment and selection purposes. Unless required by law, we will not provide these data to other persons or bodies, not belonging to Foodjet or its subsidiaries, without the applicant's prior consent. Applicants' data will be deleted no later than four weeks after the application procedure has ended, unless the personal data is retained with the applicants' consent, for one year after the end of the application procedure for the purpose of possible future vacancies.

(D) Information requests via info@foodjet.com

2. On what grounds do we process personal data

We will only process personal data insofar as we have a legal basis (provided by the GDPR) to do so. We may process personal data based on one of the following grounds:

- Consent provided by you as a (potential) customer;
- Where there is a contractual obligation;
- To meet our legal obligations under national legislation;
- For our legitimate interests, but only after having checked that the fundamental rights and freedoms of you as an individual, whose data we are processing, are not seriously impacted.

3. How we might share personal data

We may share personal data with the following parties:

- Youman HR for the applicants information we receive;
- ProcesPartners as IT and system administrator;
- Ridder Data Systems for all customer information and contracts;
- DaaD for all employer salary administration.

Were necessary, we will conclude contractual arrangements with the parties with whom we share personal data. Furthermore, we may disclose your data if such disclosure is required by law, or is in response to a legal request.

4. How do we secure personal data

We have implemented appropriate technical and organizational measures to protect your personal data against accidental or unlawful destruction or accidental loss, alteration, unauthorized disclosure or access and against all other forms of unlawful processing. Also, we require our data processors to implement such appropriate technical and organizational measures.

5. When will we remove personal data (retention periods)

We will store personal data for as long as necessary in light of the purposes for which the personal data is collected, unless otherwise required by law. If you chose to opt-out from communications, we will delete the data, unless this data is required for another purpose set out in this policy or if we are required by law to retain the data.

6. Your rights

You may contact us by using the contact details at the bottom of this privacy statement, if you wish:

- To know whether or not we process your personal data and access your personal data;
- To rectify your personal data;
- To erase your personal data;
- To restrict your personal data;

- To object against the processing of your personal data; and/or
- Us to transmit your personal data to another organization.

We may request provision of additional information necessary to confirm your identity. We will provide information on the actions taken without undue delay and we will respect the applicable legal time frames in this respect.

We will be happy to help you if you have any complaints about the processing of your personal data. Pursuant to the privacy legislation, you have the right to lodge a complaint with the Dutch Data Protection Authority (Autoriteit Persoonsgegevens) at any time.
